The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session or the seventh day after enrollment whichever is later.

If a student has received federal student financial aid funds the student is entitled to a refund of moneys not paid from federal student financial aid programs funds.

If the student obtains a loan to pay for an education program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.

Refund Policy and Procedure

When a Learner requests a program cancellation, to withdraw from HOLLYWOOD INTERNATIONAL UNIVERSITY USA, or to drop a course, the refund policy will apply. Tuition refunds are issued when a learner prepays a portion or all of the tuition for the course session or program and a credit is due per the schedule below. Program Cancellation and Withdrawal

Learners who withdraw from HOLLYWOOD INTERNATIONAL UNIVERSITY USA are subject to the following:

The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after the enrollment, whichever is later.

- A program cancellation request must be in writing via email to the Registrar.
- The date of the email receipt must be within attendance at the first class session or the seventh day after the enrollment, whichever is later.
- Application Fee is nonrefundable.
- A full refund of all monies paid to date (minus the application fee) will be returned within 30 days.

After attendance at the first class session, or the seventh day after the enrollment, whichever is later.

- A request to withdraw from HOLLYWOOD INTERNATIONAL UNIVERSITY USA and cancel the program by written notification to the Registrar.
- The date of the email receipt is the effective date of withdrawal
- A final reconciliation of the learner's account will be conducted. Application fee is non-refundable.
- HOLLYWOOD INTERNATIONAL UNIVERSITY USA will notify a learner if an account balance is due. Payment for account balances is due in full immediately.
- Learners with unpaid account balance are sent a reminder notice of the University's collection policy after 15 days.
- Unpaid account balances due will be turned over to collections after 31 days.
- Refunds will be paid within 30 days of the withdrawal date.

Distance Education (HIU USA Online)

Hollywood International University USA shall transmit the first lesson and any materials and access to all library and books to any student enrolling a distance education program (HIU USA Online) within seven days after the institution accepts the student for admission.

Students enrolling in a distance educational program (HIU USA Online) shall have the right to cancel the enrollment agreement and receive a full refund before the first lesson and material and access to all library and books are received. Cancellation is effective on the date written notice of cancellation is sent. Hollywood International University USA shall make the refund pursuant to section 71750 of the Regulations. If HIU USA sent the first lesson and materials before an effective cancellations notice was received, HIU USA shall make a refund within 45 days after the student's return of the materials.

Hollywood International University USA shall transmit all lessons and materials to the student if the student has fully paid for the educational program and, after having received the first lesson and initial materials and access to all library and books, requests in writing that all of the material be sent. If HIU USA transmits the balance of the material as the student request, HIU USA shall remain obligated to provide the other educational services it agreed to provide, but shall not be obligated to pay any refund after all of the lessons and materials are transmitted.

Payment Plans and Fee Information

- Learners utilizing financial assistance programs are responsible for timely payment of tuition and fees.
- Learners must pay their financial obligations to HOLLYWOOD INTERNATIONAL UNIVERSITY USA (HIU USA) before receiving reimbursement from their financial assistance source.
- Learners are encouraged to use the same tuition payment method for their entire program to avoid a Change Payment Plan Method Fee. This fee is charged each time a learner uses a combination of payment methods.
- A Late Payment Fee is charged if a learner fails to meet the terms and conditions of his or her payment plan.
- A Returned e-Check Fee is charged when a learner's payment by e-Check does not clear the Learner's bank account.
- A Denied Credit Card Fee is charged when an issuing credit card company denies a learner's payment by credit card.
- A Return Processing Fee charged when the Accounting Office receives a request to return funds.



TUITION PAYMENT PLANS

Pay-in-Full (Length of Program)

Learners may pre-pay the tuition for their entire degree program at any time during their program at HOLLYWOOD INTERNATIONAL UNIVERSITY USA. Such pre-payment will confirm the tuition rate for the duration of the learner's entire program (excluding additional or retaken courses).

Pay-by-Course

Tuition is due at the time the Learner requests his or her course(s). HOLLYWOOD INTERNATIONAL UNIVERSITY USA

reserves the right to change the tuition rate, as it deems necessary.

HIU USA Payment Plan - 33% down and two equal consecutive monthly payments

This is an interest-free, monthly payment plan that covers the direct HIU USA tuition costs for each course only.

- At the time of a learner's course request, a payment equal to 33% of the total course tuition and applicable fees, plus a \$25 Monthly Payment Plan Processing Fee is due.
- Two equal, consecutive monthly payments in the amount of 33% of the total course tuition and any outstanding account fees are due between the 15th and 20th for each of the two months following the initial payment, regardless of the start date of the course.
- Learners may accelerate the completion of their 8/10/ or 12 -week courses; however, Learners cannot register for a new course until all outstanding tuition and fees are paid in full.
- HOLLYWOOD INTERNATIONAL UNIVERSITY USA reserves the right to change tuition, as it deems necessary.

Steps for Engaging the HOLLYWOOD INTERNATIONAL UNIVERSITY USA Payment Plan:

Step One: Learner submits a Program Request through their Learner site.

Step Two: When the Dean approves the Program Request, the learner must pay 33% of the total tuition for the course, applicable

Step Three: Fees, plus a \$25 Monthly Payment Plan Processing Fee per course. The Learner's two remaining monthly payments will be due between the 15th and 20th of the two months following the initial payment, regardless of the course start date or whether the learner completes the course work in advance of the final due date. Final grades will be withheld until all fees for the course are received.

Tuition Payment Methods:

- Credit Card: The learner's credit card on file is charged *automatically between the 15th and the 20th of each month* until tuition and fees for the term are paid in full.
- Check: Check payments, accepted only in Delaware, USA, *must be received by the 15th of each month* until tuition and fees for the term are paid in full, otherwise a Late Payment Fee is charged.
- Fees: A \$25 Late Payment Fee will be charged for each month that a payment is not received on time.

If a credit card payment is declined or a PayPal payment returned due to insufficient funds, a \$25 Declined Credit Card or Returned to PayPal Fee will be charged.

- If a Learner who has prepaid tuition withdraws or is dismissed from his or her degree program prior to graduation, any tuition reduction applied to such tuition prepayment is invalid. The Learner will be charged the applicable tuition for all completed courses based on the full tuition rate as of the time of prepayment.



If a student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.

Course Drop Policy and Procedure

A learner may drop a course by notifying the HOLLYWOOD INTERNATIONAL UNIVERSITY USA via priority email.

The date of the email receipt is the effective date of the course drop. course Drop Fee is charged and due at the time of the written request.

Learners may pay online.

See Tuition and Academic Fees chart above for amount of the Course Drop Fee.

Tuition Refunds must be requested and will result in a Return Processing Fee, if they are not applied to the tuition for another course.

Meeting Financial Obligations

Importance of Meeting Financial Obligations

HOLLYWOOD INTERNATIONAL UNIVERSITY USA considers all financial obligations payable immediately, unless otherwise stated. Upon completion of the degree program, any outstanding financial balance is due and payable immediately. Certificates, diplomas, and transcripts will be withheld and will prohibit learner participation in the graduation ceremony and/or the conferring a degree until all unpaid financial obligations have been satisfied.

Personal Responsibility

It is the personal responsibility of each applicant and individual learner to determine the payment of his or her education.

Default of Financial Obligation

If the Learner's financial obligations are in default (defined as not paying a financial obligation within 30 days of the due date), HOLLYWOOD INTERNATIONAL UNIVERSITY USA may declare the entire balance due without further notice and require full payment immediately. Failure to pay the unpaid balance within 10 days may result in any or all of the following:

- Denial of registration, transcripts, diplomas, grades, and graduation
- Assignment of the account for collection
- Reporting the delinquent account status to International Credit Bureaus
- Financial dismissal from the University

If a learners account is turned over for collection, the learner is obligated to pay collection expenses.

If the student defaults on a federal or state loan, both of the following may occur:

The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan

The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance at another institution until the loan is repaid.
